WINTER TAXES ARE PAYABLE DECEMBER 1, 2025 – FEBRUARY 17, 2026 WITHOUT PENALTY

A **3% penalty** and **1% interest** charge will be added as of **February 18, 2026** to any 2025 Summer or Winter amount owing. Ida Township can only collect taxes **thru March 2, 2026**. On March 3, 2026 any taxes owing must be turned over to the Monroe County Treasurer's Office for collection.

The township office will reopen on Monday, January 5, 2026

CLOSED: Monday, January 19, 2026 – Martin Luther King Jr. Day

CLOSED: Monday, February 16, 2026 – Presidents Day

The LAST day to pay taxes at Ida Township is Monday, March 2, 2026.

We will be open 9:00 a.m. till 5:00 p.m. on that day.

Checks are accepted only as conditional payment of taxes. If payment is denied upon presentation to the bank, the tax will be considered unpaid and will be restored to the tax roll without further notice. There will be a **\$20.00** charge for checks returned to the Treasurer. **Please note:** Per Michigan Law – failure to receive tax bill does not waive late payment penalties.

If you have filed bankruptcy, this bill is for informational purposes only.

OFFICE HOURS: Monday and Wednesday 9:00 AM to 4:00 PM

OUTSIDE DROP BOX: Near Township Office front door (**NO CASH PLEASE**)

PAY AT BANK: First Merchants Bank (**ONLY AT THE IDA BRANCH**)
You do NOT have to be a member to make payments there; non-member payments must be made via check only. FMB members may pay with cash or check.
